In partnership with the Canadian Sport Institute - Atlantic and Sport Nova Scotia's Support4Sport Program, our 2025 Athlete Performance Program is now accepting applications. Our main goal is to support the journey of Nova Scotian athletes, whose goal is to represent Nova Scotia at designated national & international championships and qualify for Equestrian Canada's National Team programs.

The program is based primarily on competition results from the last 3 years (some exceptions apply). Athlete allocation into the program begins at Tier 1, then Tier 2 and so on until space is full. Although our target age is athletes under 25 years, athletes of any age may be accepted, based on the Long-Term Equestrian Development Model. As such, we encourage all athletes who meet the eligibility criteria to apply.

Tier-dependent, athletes are provided with mental performance training, fitness assessments, strength and conditioning, performance coach check-ins, athlete (human and equine) nutrition sessions, athlete's coach and parent engagement opportunities, training camps, peer support and mentoring.
